2.1 Procedure of submitting requests and orders

Normal test train

If the route of the normal test train crosses the track network managed by only one IM regional ~~centredirectorate~~, the permit shall be requested at the Operation Control Department of the affected IM Regional Traffic ~~CentreDirectorate~~; if the route of the normal test train crosses track networks managed by more than one IM Regional ~~CentreDirectorate~~, the permit shall be requested at BRK (IM Traffic ~~CentreDirectorate~~, Operation Control Department, Domestic Business of Exceptional Consignment).

Special test train

Introduction of the special test train has to be requested 10 working days before the train-run at BRK (IM Traffic ~~CentreDirectorate~~, Operation Control Department, Domestic Business of Exceptional Consignments).
