Applications for taking-over permission shall be submitted to organisations as follows:

- In the event of international transport: MÁV Zrt, Vice-presidential Organisation for Infrastructure operation, Directorate-General for ~~Infrastructure~~ **Traffic and Operation** management Unit, Operation Control Centre, International Business of Exceptional Consignments (NRK)
- In the event of domestic transport: MÁV Zrt, Vice-presidential Organisation for Infrastructure operation, Directorate-General for ~~Infrastructure~~ **Traffic and Operation** management, Traffic Operational Unit, Operation Control Centre, Domestic Business of Exceptional Consignments (BRK)

2. Procedure of submitting requests and ordering of test trains

Licensing and running of test trains are regulated in accordance with Traffic Instructions F2 Annex 1529. with the following amendments.

2.1. Procedure of submitting requests and orders

Normal test train

Introduction of the normal test train has to be requested 3 ~~working~~ **calendar** days before the train-run.
